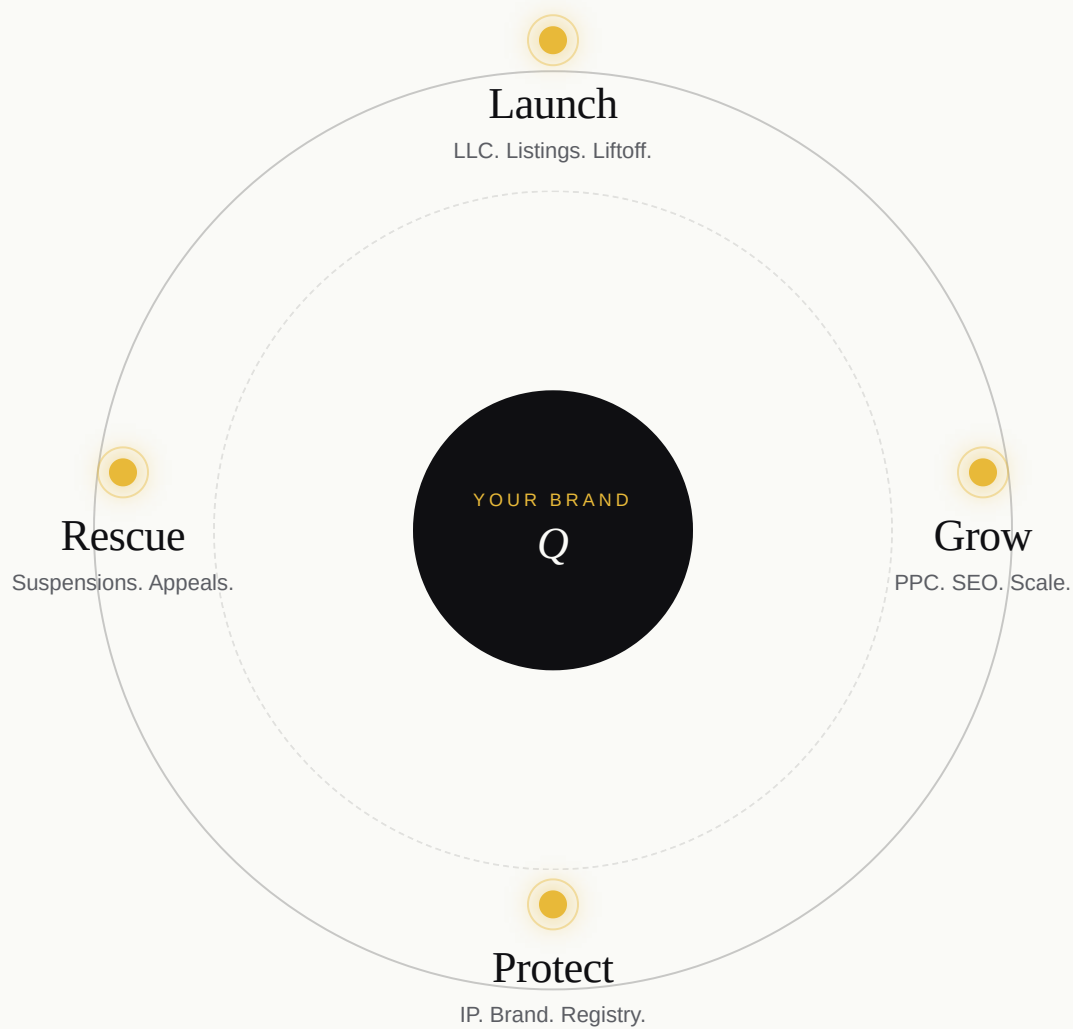

CASE STORY · ANONYMISED

A first-time seller went from *idea to £18k/month* in 7 months.

A UK-based first-time seller came to us with a pet-care product concept and £6,000 in starting capital. No LLC, no Amazon account, no supplier.

We formed the UK Ltd, registered VAT, sourced a manufacturer in Vietnam, built the listing with full A+ Content, and launched on Amazon UK with a tightly-budgeted PPC ramp.

By month 7, the brand was clearing £18,000 in monthly revenue with a 32% margin — and ready for Amazon US expansion.

CASE STORY · ANONYMISED

A struggling £80k brand became a *£1.2M-a-year* operation in 14 months.

A US-based health supplement brand was stuck at £80k annual revenue. Their PPC ACOS was running at 78%, killing margins. Listings ranked outside the top 100 for primary keywords.

We rebuilt the keyword strategy from scratch, restructured campaigns into a tight Search/Auto/PAT framework, and ran a 90-day listing optimisation sprint with new imagery and A+ Content.

By month 14, revenue had grown 15x — and ACOS dropped from 78% to 19%.

CASE STORY · ANONYMISED

A premium kitchen brand had *23 hijackers removed* in 11 days.

A UK kitchen-tools brand approached us after 23 third-party sellers had hijacked their best-selling listing, sending fakes and tanking reviews to 2.8 stars within weeks.

We accelerated their Amazon Brand Registry application, filed a UK trademark in parallel, and ran a rolling DMCA + Test Buy campaign across all 23 hijackers — coordinated with Amazon's Brand Protection team.

All 23 unauthorised listings removed in 11 days. Review rating recovered to 4.6 stars within two months.

CASE STORY · ANONYMISED

A £2M Amazon account was restored in *9 days* — after a Section 3 ban.

A long-established US supplement brand was hit with a Section 3 suspension after a single restricted-products policy violation. Amazon held US \$87,000 in pending payouts. Internal team and prior agency had appealed twice and failed.

We took the case at midnight on a Saturday. By Monday we had a re-engineered Plan of Action, a complete document package, and a personal escalation through our policy contacts.

Account fully restored in 9 days. All pending funds released. Zero recurrence in 18 months since.
